Formed in 1945, the Health Unit employs more than 100 employees led by a Board of Health, Medical Officer of Health, and Chief Executive Officer. The Health Unit strives to deliver high quality programs and services to address the unique health needs of our community and improve the health and well-being of our population.

We collaborate with other organizations including government, police, schools, and community agencies. Together we combine our expertise to plan and deliver programs and services in our community. Our partners are also vital in helping to reach our priority populations.

Practicing Good Governance

In Ontario, each heath unit is governed by a Board of Health in accordance with the Health Protection and Promotion Act.

The Brant County Health Unit's Board of Health is made up of two representatives from the County of Brant, three representatives from the City of Brantford, and four representatives appointed by the Province of Ontario.

Processes

Public health staff, including nurses, inspectors, dental and nutrition staff, epidemiologists, health planners, health promoters, and support staff deliver the Ontario Public Health Standards.

Staff collaborate with community partners and deliver health promotion, disease prevention and health protection services through a variety of individual and population-based strategies.

These strategies include, but are not limited to, home visits, inspections, policy development, social marketing, clinic services, community development, and health education.
